### **Fall 2023 Harvest Procedures and Updates**

Harvest is quickly approaching, and we all know how it can be a hectic and stressful time. To better serve you, below there are a few updates we would like to share to make harvest as seamless as possible.

#### Ticket Split Update

Included are the current ticket splits we have on file for your account. If there are any changes or additions to your ticket splits, please reach out to your local grain office as quickly as possible so we can make changes in preparation for harvest. If you would like additional farm information on your tickets, please let us know that as well. Although we may not be able to accommodate every need, there are additional comment fields that may be utilized at the scale.

#### Ticket Application Procedures

When hauling grain to an Ag Partners facility this fall, please keep in mind all contracts will be filled first. If there is no contract available, the bushels will default to the Delayed Pricing program. If you do not want your bushels to default to Open Storage or Grain Bank, please contact the Hiawatha or Seneca grain office and we will coordinate with the location you deliver to.

#### Updated Storage Charges and Changes

As you may have seen posted at locations and in the Quarterly Newsletter, we have made changes to our storage charges and procedures. We currently are charging the storage at the time of settlement. However, starting September 1, 2023, the accrued storage will be billed annually. The only storage charges that will be billed in 2023 will be for any open storage/grain bank delivered prior to September 1, 2022. This will leave one year's worth of storage to be deducted from the check at settlement time. In the future, open storage/grain bank charges will accrue from delivery until September of the following year; at which point it will be billed. The Delayed Pricing program fee will still be deducted at the time of settlement.

We have also increased our storage fee due to increased maintenance costs, inflation, and other operational expenses. The storage rate on open storage and grain bank will be increasing from 5 cents to 6 cents per bushel per month, starting September 1, 2023. Any grain delivered prior to this date will continue being billed at 5 cents a bushel. Our Delayed Pricing program rates will remain unchanged at 4 cents a bushel.

#### Checks

Ag Partners will not be issuing any checks unless requested. If you or your landlord would like to have a check mailed or one be available for pick up at Hiawatha, Seneca, Sabetha, St. Mary's, or Tarkio please call the Hiawatha or Seneca office.

#### DP Pricing

If you have corn or beans in our Delayed Pricing program from 2022, that grain will need to be priced by October 31, 2023.
