GENERAL INFORMATION

Agtegra AR_x Rivet™ is recommended for use with sulfonyleurea (SU) herbicides and herbicides that suggest the addition of ammonium sulfate (AMS), UAN, or a nonionic surfactant (NIS).

DIRECTIONS FOR USE

NOT FOR AQUATIC USE.

The addition of nitrogen based fertilizers (such as 28% N, or 10-34-0), or ammonium sulfate, are generally not required with Agtegra AR_x Rivet. Follow herbicide label directions.

Use Agtegra AR_x Rivet at 0.5 - 1% v/v (2 - 4 quarts per 100 gal spray mixture).

For water volumes below 5 gpa, use 1 - 2% v/v (1 - 2 gal per 100 gal spray mixture).

Add Agtegra AR_x Rivet last to spray mixture and continue agitation, or follow specific tank filling and mixing information provided on the herbicide label. Refer to the herbicide label for additional recommendations or precautions.

HANDLING AND STORAGE

DO NOT STORE BELOW 0° F.

IF FROZEN, WARM CONTAINER AND SHAKE WELL BEFORE USING.

Storage: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies.

Disposal: Do not contaminate water, food or feed by storage or

disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
