The forgoing consent is revocable by the member in writing received by the Coop, PROVIDED HOWEVER, that such revocation is effective with respect to patronage occurring after the close of the Coop's fiscal year during which said written revocation is received. THE PATRON'S/MEMBERSHIP'S CONSENT IS REQUIRED FOR THE COOP TO RECEIVE AN INCOME TAX DEDUCTION FOR ITS PATRONAGE ALLOCATIONS, pursuant to Sub-Chapter T of the Internal Revenue Code, 26 U.S.C., Sections 1381 through 1388. By signing said consent, the Patron agrees to include the total amount of any patronage allocation or dividend (not just the cash portion thereof) in Patron's gross taxable income in the year during which qualified written notice of allocation is received. While you are required to sign the foregoing consent, it relates to Patron only to the extent that Patron's purchases from the Coop, or sales to the Coop, are related to Patron's taxable income.
