OPEN ACCOUNT

- 1. An approved credit application must be on file.
- 2. Purchases billed monthly, and statement mailed.
- Payment is due in full by the 15th.
 Example: Patron charges in April, receives statement May 5th. Balance is due by May 15th.
- 4. If account is not paid in full by the due date, patron's account will be assessed 1.5% per month finance charge (18% A.P.R.) (minimum 1.00), on the unpaid balance.
- 5. Payments shall be applied to oldest invoice first.
- 6. Legal action taken on past due accounts, and patron placed on C.O.D.
- 7. All purchases must be signed for.

BUDGET ACCOUNT

- 1. Used for home heating, no extra charges, receive current price on products if account is current.
- 2. Placed on a scheduled delivery program.
- 3. Estimated yearly usage is divided into eleven monthly payments.
- 4. To qualify, your account must be paid up to date and you must have an approved credit application on file.
