- .10 Down Booking Program Price will be 5 cents higher than 100% Full Prepay Purchase contract. The down payment will be deducted from your account at time of delivery. The balance is due the 15<sup>th</sup> of the following month per CRC Standard Credit terms.

#### **Terms & Conditions**

- All contracted gallons will be delivered prior to any cash/rack purchases during contract period.
- Only current CRC accounts are eligible for contracting.
- All contracts are non-transferable.

## **Terms of Payment**

Overbooking / Pricing Chargeback – Unused contract gallons or refusal to take delivery of contracted gallons prior to the expiration date of the contract will result in a penalty calculated by the difference in contract price as stated in this agreement and rack price at the time of contract expiration multiplied by the remaining contract gallons plus .10 cent per gal to be invoiced at the end of the contract period.

Additional Freight Fees – Contracts with Central Region Cooperative are based on refined fuels products being procured at the Mankato, MN terminal. If supply dictates that refined products have to be procured at other terminals, additional freight and pipeline fees will be applied to contract values. Any additional State clean up fees or mandatory taxes not in place at time of contract execution will be invoiced upon delivery of contracted gallons.
