Central Region Cooperative Electronic Signature Disclosure and Consent

This Electronic Signature Disclosure and Consent (“Consent”) sets forth the terms and conditions governing my consent to receive and sign documents electronically with Central Region Cooperative (“CRC”) and any of its successors.

I may decline to electronically sign any document by not signing the document electronically; however, my failure to sign will still mean that I received CRC’s written confirmation electronically and accepted the terms of such written confirmation unless I immediately notify CRC of any differences between the written confirmation and my agreement with CRC by rapid written communication or by telephone confirmed by subsequent written communications. By providing this Consent, I acknowledge that for grain contracts this electronic means of communication is a viable method of contractual communication in accordance with the National Grain & Feed Association Trade Rules.

Required Hardware and Software

Operating Systems: Windows 7 or above, Mac OS X or above, iOS 9.0 or above, Android 6.1 or above

Browsers: Mozilla Firefox 48.0 or above; Safari 5.0 or above (Mac or iOS only), Google Chrome v53 or above.

By using the CRC system program, I confirm that I have the required hardware and software to use the CRC system program, including viewing, downloading, printing and electronically receiving such documents.

At any time, I may contact CRC and request a paper copy of any document signed electronically through the CRC system program, at no cost.

Effect of My Consent

By agreeing to this Consent, I understand that (i) I consent to CRC sending me documents (including, without limitation, grain and other contracts and bookings) to the email address I have provided below, and (ii) electronically signing and submitting any document(s) to CRC legally binds me in the same manner as if I had signed in a non-electronic form, and (iii) the electronically stored copy of my signature, any contract and any other document provided to me by CRC, is considered to be the true, accurate and complete record, legally enforceable in any proceeding to the same extent as if such documents were originally generated and maintained in printed form, and (iv) I accept full liability if anyone other than me shall electronically view or sign a document submitted to me electronically by CRC, and (v) I agree not to contest the admissibility or enforceability of CRC’s electronically stored copy of this Consent and any other documents signed or agreed to electronically. If I wish to withdraw this Consent than I must contact a manager of CRC in writing and request that this Consent be withdrawn. Such withdrawal of this Consent will only be applicable to future communications from CRC ten (10) days after the withdrawal of Consent is received by CRC in the manner indicated herein.
