

PROCESS:

- Early Seed Enrollment: Grower commits to crops, estimated acres, and agrees to the Terms & Conditions via a text message/email sent by Growers Edge.
 - Sellers enter information via the Growers Edge Portal with grower's name, address, email, and estimated acres.
- Identification of Acres: Growers are contacted by Growers Edge, via text message/email, to identify fields the products are placed on via Growers Edge Web-App.
 - Co-Alliance can send field boundaries to Growers Edge as a part of this step.
- Yield/Warranty Review Submission: Final yield is reported on the Growers Edge Web-App, and review is submitted if needed to Growers Edge.
 - If review is requested, Growers Edge will contact the Growers Insurance Agent for the necessary documentation.
- Warranty Reviews: Warranty Reviews are assessed and paid out.
