Gas Card Agreement

AN AGREEMENT by and between Country Partners Cooperative (Coop), and _____
(PATRON)

The terms of the agreement are as follows:

1. Upon completion and return of this form, Coop agrees to furnish at no cost to Patron, a gas card which may be used to operate the pumps at all of the Coop's locations, provided credit is approved by the credit department.
2. Patron agrees to comply with the credit policy of the Coop, which calls for payment for ALL purchases on the 15th of each month following the purchase. It is understood that if Patron fails to abide by the credit terms and does not make alternate arrangements with the Credit Department, Coop will cause Patron's gas card to be rendered invalid. In addition, Coop will require cash payments FOR ALL PURCHASES until Patron's account is current on all purchases, at which time, Coop may once again permit Patron's gas card to operate the fuel systems.
3. Coop warrants that while the price of the fuel will be competitive, Patron understands that said price is subject to change without notice and Patron will pay prevailing price at the time of delivery, which will be posted on the pump. Pump prices will prevail over prices posted on any sign.
4. In addition to any other purchases, Patron agrees to reimburse Coop for all gallons delivered through the gas card system and recorded on Patron's statement. In the event of a lost or stolen gas card, Patron agrees to IMMEDIATELY notify the Credit Manager, who will promptly render that gas card invalid. Until such date and hour as Patron has so notified Coop of a lost, stolen or misplaced gas card, Patron shall remain liable for all gas card purchases recorded on Patron's statement. Upon notification of the loss or disappearance of any gas card, Coop agrees to invalidate the card and issue a new card upon request by Patron, at no charge.
5. Patron agrees to abide by Federal Law requiring the exclusive use of unleaded fuels in vehicles designed for unleaded gas only.
6. This agreement shall be binding upon each of the parties, their heirs and executors.
7. This agreement may be immediately terminated by either party by written notice of intent to cancel.
8. I hereby authorize that an interest charge be assessed to the balance of any delinquent account until paid. The current Interest Rate is 1.33% per month, which equals an annual percentage rate of 16% based on a 365 day year. This rate is subject to increase in accordance with general usury laws. By signing this agreement, I agree that I am liable for all legal and collection fees. I have read this application and agree to abide by all conditions listed herein.
