NEW EQUIPMENT WARRANTY

Application Qualifiers

- Has a diesel engine with 50 horsepower or greater
- Has less than 400 hours of service
- Is no more than 6 months from acquisition

Irrigation Agricultural Equipment:

- Has less than 750 hours of service
- Is no more than 60 days from acquisition

Application Process

- 1. Complete and sign the New Equipment Warranty Application and Agreement of Responsibility (the "Application and Agreement") at the back of this booklet.
- 2. Work with your authorized distributor to submit the Application and Agreement, plus the warranty fee of \$799, to CHS for processing. As the warranty applicant, payment must come from you. CHS reserves the right, in its sole discretion, to approve or disapprove any Application and Agreement submitted for approval.
- 3. CHS will review your Application and Agreement and notify you if it is approved by sending you an Approval Welcome Kit detailing your coverage and containing tools to assist you in maintaining your warranty coverage. A New Equipment Warranty number will be assigned for use in identifying oil samples and to expedite related correspondence.

WARRANTY TRANSFER

Transferring Coverage

Agricultural equipment* currently covered under the Cenex Total Protection Plan® warranty can be transferred when there is more than six months remaining in the warranty term, and all prior operator responsibilities have been fulfilled.

Several requirements are necessary for the warranty to be transferred to a new operator who either owns (or leases) and operates eligible equipment within the CHS Energy trade territory.

Transferee must complete the New Equipment Warranty Application for the transferred equipment. Application must be submitted to the authorized distributor from whom the transferee will purchase Cenex® Covered Fluids for the Components covered under the warranty within 30 days of transfer. The operator must fully comply with obligations outlined in the Agreement of Responsibility found in the New Equipment Warranty Application. Coverage is limited to the original warranty term.

Coverage Length

Equipment is covered until it reaches specified years in service from date of manufacture, or it accumulates specified hours, whichever occurs first.

For example, for 8 years/8,000 hours of coverage, if your equipment has accumulated 2 years or 1,400 hours, the remaining coverage is 6 years or 6.600 hours.

IMPORTANT: The used equipment plan requires two, approved LubeScan® Used Oil Analysis fluid samples within 24 months to verify equipment is in good condition before the plan is activated.

Please note: The use of Cenex® Ruby Fieldmaster® Premium Diesel Fuels includes the use of Cenex Ruby Fieldmaster Seasonally Enhanced and Cenex Wintermaster®.

Winter-blending Ruby Fieldmaster:

Used Equipment **Standard Component Coverage**: Up to 8 years old from date of manufacture or 8,000 hours, whichever comes first

Used Equipment **Expanded Component Coverage**: Up to 2 years old from date of manufacture or 2,000 hours, whichever comes first

Application Process

- Complete and sign the Used Equipment Warranty Application and Agreement of Responsibility (the "Application and Agreement") at the back of this booklet.
- 2. Arrange for an authorized Cenex® representative from your authorized distributor to:
 - Assist you completing an identification inspection
 of the equipment to be covered, and include a
 LubeScan® Used Oil Analysis engine oil sample
 for submission to CHS. If applicable, also submit
 LubeScan samples for the transmission and/or
 hydraulics if applying for Expanded Component
 Coverage. LubeScan Used Oil Analysis sampling
 kits are available from your authorized Cenex
 distributor.
 - Verify date of manufacture of equipment and accumulated operating hours.
- 3. Work with your authorized distributor to submit the Application and Agreement, plus the warranty fee of \$799, to CHS for processing. As the warranty applicant, payment must come from you.
 - CHS reserves the right, in its sole discretion, to approve or disapprove any Application and Agreement submitted for approval.

- 4. CHS will test and analyze the fluid sample. If no evidence of mechanical defects in lubricated-covered components is detected, the equipment will begin a 100-hour screening period during which the equipment operator agrees to:
 - Replace all applicable Covered Fluids with approved Cenex products.
 - Operate the covered equipment in normal operating conditions.
 - Submit a second engine oil and/or transmission/ hydraulic fluid sample(s) (following the 100-hour screening period) to CHS for analysis.
- 5. CHS will review the second set of fluid samples along with the Application and Agreement and notify you if the second set of fluid samples are approved by sending you an Approval Welcome Kit detailing your coverage and tools for maintaining warranty coverage. A Used Equipment Warranty number will be assigned for use in identifying oil samples and to expedite related correspondence.

WARRANTY TRANSFER

Transferring Coverage

Agricultural equipment currently covered under the Cenex Total Protection Plan® warranty can be transferred when there is more than six months remaining in the warranty term, and all prior operator responsibilities have been fulfilled.

Several requirements are necessary for the warranty to be transferred to a new operator who either owns (or leases) and operates eligible equipment within the CHS Energy trade territory.

Transferee must complete the Used Equipment Warranty Application for the transferred equipment. Application must be submitted to the authorized distributor from whom the transferee will purchase Cenex Covered Fluids for the Components covered under the warranty within 30 days of transfer. The operator must fully comply with obligations outlined in the Agreement of Responsibility found in the Used Equipment Warranty Application. Coverage is limited to the original warranty term.



DIESEL ENGINE

Coverage limited to the internal lubricated parts.

Not Covered: Cylinder head assembly, valves/valve guides, oil pump and oil cooler, engine block, oil seals, oil filters, turbocharger, non-lubricated parts, external parts such as vibration dampener, and hydraulic fan motors.








<u>DIESEL FUEL INJECTION PUMP/HIGH PRESSURE PUMP</u> AND INJECTORS

Not Covered: Fuel lines and filters



TRANSMISSION, HYDRAULICS, FINAL DRIVE, DIFFERENTIAL/HUBS

Not Covered: Auxiliary equipment, including added implements and their associated valves and pumps, bogie and idler wheels, reaction/torsion arms, hydraulic lines, hydraulic fan motors, couplers, oil coolers, cab/seating, and steering hydraulics.




Illustration of covered parts.



FREQUENTLY ASKED QUESTIONS

1. How often do I submit used fluid samples for each component?

A: For all components listed, used fluid samples should be submitted at minimum annually. In addition, consider these guidelines for submitting used fluid samples:

Engine: Submit used fluid sample at each oil change or drain **Transmission/Hydraulics/Final Drive (common sump):** Submit used fluid sample every 300 hours

Transmission only: Submit used fluid sample every 300 hours **Hydraulics only:** Submit used fluid sample every 300 hours **Differentials and Hubs:** Submit used fluid sample annually **All other covered components:** Excluding fuel-related components, submit a used fluid sample annually

2. Where do I submit these fluid samples?

A: Use the pre-printed ALS labels from your Approval Welcome Kit, on your Sample Identification Form (included with official LubeScan® Used Oil Analysis sample kits available from your authorized Cenex® distributor) when submitting samples to ALS Tribology to ensure that your LubeScan sample is processed correctly. Mail your filled sample container with correctly labeled and completed Sample Identification Form, and using a black mailing canister and/or mailing sleeve, to ALS Tribology lab: LubeScan, 935 Sunshine Road, Kansas City, KS, 66115-1122. Download the user-friendly ALS Webtrieve™ Mobile app for faster sample entry.

3. Can the warranty transfer?

A: Agricultural equipment* currently covered under the Cenex Total Protection Plan® warranty can transfer when there is more than six months remaining in the warranty term. Several requirements are necessary for the warranty to be transferred to a new operator who either owns (or leases) and operates eligible equipment located within the CHS Energy trade territory. The Transfer and the applicable Cenex Total Protection Plan New or Used Equipment Warranty Application must be delivered to an authorized distributor within 30 days of transfer. The operator must fully comply with obligations outlined in the Agreement of Responsibility found in the New or Used Equipment Warranty Application.

4. How do I make a claim?

A: Before making a claim, contact the distributor where you purchased the Cenex lubricants and Cenex Ruby Fieldmaster® Premium Diesel Fuel products used in the covered equipment or the local Cenex or CHS representative providing the Cenex Total Protection Plan® warranty application. When a covered component shows signs of failure, a used oil sample and/or fuel sample are to be submitted using a LubeScan Used Oil Analysis kit or appropriate fuel kit container to CHS. Samples must be submitted before repair work is initiated. It is important to retain all replaced parts as should your claim need additional review during the claims process, CHS Technical Services may inspect failed or replaced parts. After the claim, repaired components must be refilled with Cenex Covered Fluids to ensure continued warranty coverage. A warranty holder must submit an invoice for the claim within 90 days from final invoice date.


