THE PATRONS/MEMBER'S CONSENT IS REQUIRED FOR THE COOPERATIVE TO RECEIVE AN INCOME TAT DEDUCTION FOR ITS PATRONAGE ALLOCAIONS, pursuant to Subchapter 1 of the Internal Revenue Code of 1954, Sections 1381 thru 1388. By signing said consent, the patron agrees to include the total amount of any patronage allocation or dividend (not just the cash portion) in his/her gross taxable income in the year during which qualified written notice of allocation is received. While you are required to sign the forgoing consent, it is related to you only to the extent that your purchases form the Association or sales to the Association that are related to your taxable income.
