



**Please read as contract details have changed.**

Dear Patron,

Enclosed you will find your L.P. contract paperwork. This year, the contract is one page for both budget and prepaid contracts. Please check the box next to Prepaid, Budget, or No Contract. The gallons are auto populated from last year's usage from 09/01/21 through 04/30/22 and rounded up to the nearest 100 gallons. This number does not include summer fill gallons.

Payments are calculated for your convenience. You are welcome to change the gallons, please write the changes next to the populated numbers and calculate your new payment. If purchasing LP as a business that pays sales tax, please add 6% to your contract total.

### **Contract Instructions**

- If you check the "Prepaid" box, please check the first or second delivery option, sign, date, and mail back with a check for the total amount.
- If you check the "Budget" box, please check the first or second delivery option, sign, date, and mail back with a check for the first budget payment. Budget payments begin in August and run through May for a total of 10 payments. First payment with contract counts as August payment.
- If you check the "no contract" box, please check the first or third delivery option, sign, date, and mail back.

**Prices are subject to change after July 31<sup>st</sup> 2022.**

We will go by postmark to determine which price you will receive.

**\*\*MINIMUM 300 GALLONS CAN BE CONTRACTED\*\***

This year's contract will cover the L.P. gas that you will need for your home heating. This is a non-transferable contract. All contract customers will be on a SCHEDULED ROUTE delivery basis until all contract gallons have been delivered or expiration of contract date, whichever comes first. This is so our drivers can deliver on regular routes.

The L.P. home heat contract gallons will be in effect from **September 1<sup>st</sup>, 2022 through March 31<sup>st</sup>, 2023.** Delivery options will be in effect from **September 1<sup>st</sup>, 2022 through August 31<sup>st</sup>, 2023.** This date range covers summer fill for 2023. Customer agrees to purchase the stated amount of the LP gas at the contract price, within the specified time period. Any unused gallons will go away at that price, and any remaining money will show as a credit on your account. **Past Due or C.O.D accounts are not eligible.**
