#### Purchase and Sale Agreement SUMMARIZED Conditions

- 1. If product is not paid for by agreed upon due date, the cash discount will be forfeited and finance charges apply. Customer is still liable for the purchase he/she agreed upon.
- 2. Pro Coop is responsible for providing product that has the correct specifications agreed upon in contract. Product quality is not guaranteed other than good faith and effort on Pro Coop's part.
- 3. Pro Coop promises to deliver or supply the agreed upon products with exceptions of extreme circumstances reasonably out of its control. This includes but is not limited to: sudden supply chain interruptions or shortages, 3<sup>rd</sup> party transportation issues, government regulations, or Acts of God. In this case, the customer is only financially liable for the product that Pro Coop is able to deliver according to contract.
- 4. Any quantity purchased over the original contracted amount will be priced at that day's posted price per unit.
  - a. If customer does not take product by the end date specified:
    - i. Pro Coop has the right to void the remaining balance
    - ii. Pro Coop has the right to charge the customer the contracted price or the posted price on day of delivery for any contracted gallons delivered after the expiration of the contract; this is in addition to a cancellation fee of 20% of the value of the remaining quantity. Pro Coop may alternatively cancel the balance of Customer's contract to purchase such undelivered Product and/or terminate this Agreement.
- 5. If product becomes in short supply, those who have prepaid bookings will be allocated product first. Pro Coop can choose to allocate gallons amongst these contracted customers as long as it doesn't prevent one customer from timely operations over another. The customer will not be held liable for any product he/she has booked that cannot be delivered upon by Pro Coop.
