For the prevention of coccidiosis caused by *Eimeria ovina*, *Eimeria crandallii*, *Eimeria ovinoidalis* (*Eimeria ninakohlyakimovae*), *Eimeria parva* and *Eimeria intricata* in sheep maintained in confinement.

FEEDING DIRECTIONS: Lambs should be fed at least twice daily. Feed Co-op Show Lamb Feed-BOV continuously at a rate of 1.1 to 5.0 lb per head per day to provide not less than 15 nor more than 70 mg of Lasalocid per head per day depending on body weight. To maintain rumen health and prevent digestive upset, a minimum of 0.5 lb per head per day of fine-stemmed hay should be fed in addition to the Co-op Show Lamb Feed-BOV. Do not exceed 0.30 ppm supplemental selenium in the total ration. Keep clean, fresh water available at all times. Consult your Co-op Feed Representative for directions for starting lambs on feed. Vaccinate all lambs to prevent enterotoxemia (overeating disease) with both C and D toxoid.

CAUTION: The safety of Lasalocid for use in unapproved species has not been established. Do not allow horses or other equines access to feeds containing Lasalocid as ingestion may be fatal.
