Doe and Litter (3 weeks to weaning)	Self Feed	1 to 2 lb
Growing Rabbits (4 to 7 lb)	Self Feed	4 to 6 oz
Bucks*	Limit	4 oz

* Feed according to condition. Poor reproductive performance can occur when bucks and/or does become excessively fat.

It is not necessary to feed hay with Co-op Complete Rabbit Pellets. If of high quality, hay may be fed if desired. It must be fine stemmed, leafy and well cured. Alfalfa and legume hays are suitable. Cutting the hay into 3 to 4 inch lengths will help prevent waste. Always provide plenty of clean, fresh water.
