## MEDICATED

Starter for Weaned Pigs

For control of swine dysentery (vibriotic dysentery, bloody scours or hemorrhagic dysentery); control of bacterial swine enteritis (salmonellosis or necrotic enteritis caused by *Salmonella choleraesuis*); for increased rate of weight gain and improvement of feed efficiency.

Carbadox ..... 50 g/ton

Ground Corn, Dehulled Soybean Meal, Dried Whey, Fish Meal, Animal Fat and Vegetable Oil, Sugar, Calcium Phosphate, Calcium Carbonate, Zinc Oxide, Copper Sulfate, L-Lysine, Natural and Artificial Flavors, Yucca Schidegera Extract, Choline Chloride, Vitamin E Supplement, Niacin Supplement, Calcium Pantothenate, Biotin, Menadione Sodium Bisulfite Complex, Riboflavin Supplement, Vitamin A Acetate, Vitamin B-12 Supplement, Vitamin D-3 Supplement, Folic Acid, Manganous Oxide, Ferrous Sulfate, Calcium Iodate, Cobalt Carbonate, Sodium Selenite, Ethoxyquin (a preservative).

**FEEDING DIRECTIONS:** Feed as sole ration until two weeks after weaning or until pigs weigh 25 lb whichever occurs first. Always provide plenty of clean, fresh water in clean waterers.

**WARNING:** Do not feed to swine within 42 days before slaughter.
