

# CO-OP CALF PRIMER/TCR II-RUM CL

For the prevention and control of coccidiosis caused by *Eimeria bovis* and *Eimeria zuernii*.

Monensin ..... 32 g/ton

For the prevention of adult house and stable fly emergence from the manure of treated cattle.

Diflubenzuron (CAS #35367-38-5) ..... 0.000500%

## INGREDIENTS

Roughage Products, Processed Grain By-Products, Plant Protein Products, Grain Products, Molasses Products, Propionic Acid (a preservative), Calcium Carbonate, Lignin Sulfonate, Salt, Potassium Sulfate, Magnesium Sulfate, Artificial Flavor, Calcium Phosphate, Sodium Selenite, Selenium Yeast, Magnesium Oxide, Copper Sulfate, Zinc Oxide, Zinc Sulfate, Manganous Oxide, Manganese Sulfate, Cobalt Carbonate, Ethylenediamine Dihydriodide, Calcium Iodate, Ferrous Sulfate, Vitamin A Supplement, Vitamin D-3 Supplement, Vitamin E Supplement.

**FEEDING DIRECTIONS:** Offer Co-op Calf Primer/TCR II-RUM CL at the rate of 2 lb per 100 lb of body weight per day to provide 0.32 mg of Monensin per lb of body weight and 0.1 mg of Diflubenzuron per kg of body weight per day. Intake of Monensin should not exceed 200 mg per head per day. Always provide plenty of clean, fresh water. Do not let animals run out of feed.

**WARNING:** A withdrawal time has not been established for pre-ruminating calves. Do not use in calves to be processed for veal.

**CAUTION:** Do not allow horses or other equines access to feed containing Monensin. Ingestion of Monensin by equines has been fatal. Monensin-medicated cattle feed is safe for use in cattle only. Consumption by unapproved species may result in toxic reactions. Do not exceed the levels of Monensin recommended in the feeding directions, as reduced average daily gains may result. If feed refusals containing Monensin are fed to other groups of cattle, the concentration of Monensin in the refusals and amount of refusals fed should be taken into consideration to prevent Monensin overdosing. Do not feed to sheep or other copper-sensitive animals.

## PRECAUTIONARY STATEMENTS

Causes moderate eye injury. Do not get in eyes or on clothing. Wear protective eyewear (goggles, face shield, or safety glasses). Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse. Wear long-sleeved shirt and long pants, socks, shoes and gloves.

**Storage and Disposal:** Do not contaminate water, food or feed by storage or disposal.

**Storage:** Store pesticide in original container in a dry place.

**Product Disposal:** Wastes resulting from the use of this product may be disposed of onsite or at an approved waste disposal facility.

**Container Disposal:** Completely empty bag. Then dispose of empty bag in a sanitary landfill or by incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.

## DIRECTIONS FOR USE

When used as directed, this product will provide sufficient Diflubenzuron larvacide to prevent the emergence of adult house and stable flies from manure of treated cattle. Existing adult flies will not be affected. Start feeding before house and stable flies appear and continue use until cold weather marks the end of the fly season. Feed this product at the rate of 2 lb per 100 lb of body weight per day which will provide 0.1 mg of Diflubenzuron per kg of body weight per day. Introduction of this product after an adult house or stable fly infestation is established will require treatment of cattle and confinement areas with adulticides if immediate elimination of the adult fly population is desired.
