CAUTION: Do not allow horses or other equines access to feed containing Monensin. Ingestion of Monensin by horses has been fatal. Monensin-medicated goat feeds are safe for use in goats only. Consumption by unapproved species may result in toxic reactions. Do not exceed the levels of Monensin recommended in the feeding directions, as reduced average daily gains may result. Do not feed to lactating goats.
