

CO-OP 15% PELLETTED HIGH STRESS BEEF STARTER-A+B

For Weaned Beef Cattle on Pasture Weighing up to 800 lb

For treatment of bacterial enteritis caused by *Escherichia coli* and bacterial pneumonia caused by *Pasteurella multocida* organisms susceptible to Chlortetracycline. For control of coccidiosis caused by *Eimeria bovis* and *Eimeria zuenii*.

INGREDIENTS

Processed Grain By-Products, Roughage Products, Molasses Products, Propionic Acid (a preservative), Calcium Carbonate, Animal Fat and Vegetable Oil with Ethoxyquin (a preservative), Vegetable Oil with Tertiary Butyl Hydroquinone (a preservative), Salt, Plant Protein Products, Selenium Yeast, Zinc Methionine Complex, Manganese Methionine Complex, Copper Lysine Complex, Cobalt Glucoheptonate, Sodium Selenite, Zinc Oxide, Manganous Oxide, Ferrous Sulfate, Magnesium Oxide, Copper Sulfate, Cobalt Carbonate, Ethylenediamine Dihydrochloride, Calcium Iodate, Vitamin A Supplement, Vitamin D-3 Supplement, Vitamin E Supplement.

FEEDING DIRECTIONS: This product contains 500 mg of Chlortetracycline and 22.7 mg of Lasalocid per lb and is designed to provide supplemental protein, energy, vitamins and minerals to freshly weaned or stressed beef calves. Hand feed Co-op 15% Pelleted High Stress Beef Starter-A+B continuously at 2% of body weight per day for not more than 5 days to provide 10 mg of Chlortetracycline per lb of body weight per day and 1 mg of Lasalocid per 2.2 lb of body weight per day with a maximum of 360 mg of Lasalocid per head per day along with high-quality pasture or hay and plenty of clean, fresh water.

WARNING: A withdrawal period has not been established for this product in pre-ruminating calves. Do not use in calves to be processed for veal.

CAUTION: The safety of Lasalocid for use in unapproved species has not been established. Do not allow horses or other equines access to feeds containing Lasalocid. Federal law restricts medicated feed containing this Veterinary Feed Directive (VFD) drug to use by or on the order of a licensed veterinarian. Do not feed to sheep or other copper-sensitive animals.
